In order to qualify for the City of Casey Utility Grant, a business must be a City utility customer current and in good standing with the City of Casey Utility Department with an eligible business project. All grants will be applied directly to the business utility account for gas and/or electric. Grantees will still receive a monthly utility bill during the applied grant period for water, sewer and sanitation.

The City of Casey does not award grants to home businesses.

All projects must commence after grant approval.

25% of the grant will be applied to the next month's utility bill upon grant approval and project commencement. The Committee will require progress updates which may include site visits. Upon the successful completion of the project, the remainder of the grant will be applied to the utility bill. The Committee reserves the right to revoke a grant if no project progress is seen at the first quarter, or after 90 days, whichever is longer.

Applications will be reviewed by the Economic Development Committee and awarded on a first come/first serve basis. The City of Casey reserves the right to award a partial grant and to accept or reject any applications.
